# **ZONING DEPARTMENT**

Zoning Administrator Gordy Johnson explained the code of Ordinances 2022. The Code of Ordinance 2022 is an ordinance amending the definitions, use classifications, vegetation requirements in the shoreland management ordinance, along with the fee schedule and conditional use performance section in the Township Zoning Ordinance. Terry Peterson **motioned** Jason Zastera seconded to adopt Resolution 2022-2 accepting the recommendation of the Planning Commission for the adoption of the Code of Ordinance 2022. All in favor motioned carried.

Zoning Administrator Gordy Johnson stated at the Planning Commision meeting they discussed the Dogs Running at Large Ordinance. It is to our understanding the county will not renew the dogs running large contract, if there is an issue the county will not back it. It would have to go through our own attorney. After some discussion it was recommended that we have the Dogs Running at Large Ordinance reversed. There will have to be a public hearing. Zoning

Administrator Gordy Johnson stated that it will be discussed at the next Planning Commission Meeting.

### **ROADS**

The roads are looking good. The new compressor is installed. It was recommended to put the old compressor and the lawn mower up on sealed bid. Terry Peterson **motioned** and Wayne Whited seconded to put the old air compressor and the lawn mower on sealed bid. All in favor motioned carried.

#### FIRE

The City of Pine City Administrator Scott Hildebrand and the Pine City Fire Chief Tom Miller were present to respond to attorney Mike Couri's letter regarding the fire contract. There was a very lengthy discussion on the fire contract and nothing was decided on.

#### **SEWER**

Some pumps were tripping out when it was cold. Lift station #6 has two new pumps that were installed. One of the old pumps taking out is still usable. It will be used as a backup pump.
