## **AGENDA**

Dave Deutschlander **motioned** Jason Zastera seconded to accept the agenda as written. All in favor motioned carried.

#### **APPROVE MINUTES**

Jason Zastera **motioned** Wayne Whited seconded to approve the January 11<sup>th</sup>, 2024 Regular Board meeting minutes as written. Jason Zastera yes, Wayne Whited yes, Terry Peterson yes, Darrin Freetly yes, Dave Deutschlander abstains due to being absent from the meeting, motion carried.

# **PAYROLL**

Jason Zastera **motioned** Terry Peterson seconded to approve check # 14380 through Check # 14401 includes PERA, INS, MN Revenue for a total of \$18,222.51. All in favor motion carried.

## **SEWER**

Wayne Whited **motioned** Terry Peterson seconded to approve check # 3582 through check # 3585 and check # 3587 through check # 3590 & ECE EFT \$1,800.97 for a total of \$10,775.58. All in favor motioned carried. Wayne Whited **motioned** Dave Deutschlander seconded to approve check # 3586 for \$24,776.50. Wayne Whited yes, Dave Deutschlander yes, Jason Zastera yes, Darrin Freetly yes, Terry Peterson abstains due to conflict of interest. Motion carried.

#### **TOWNSHIP**

Terry Peterson **motioned** Dave Deutschlander seconded to approve check # 14402 through check # 14411 & EFT Viastat \$176.64 and EFT Verizon \$165.10. for a total of \$7,002.98. All in favor motion carried.

#### **TREASURER**

- A. Administrative Clerk Belsheim read off the ending balances in each account with a total ending balance of \$451,767.88. The township received \$118,389.54 from FEMA. That will show up on next month's cash control statement.
- B. Belsheim asked for permission to write off uncollectable sewer user fees. These are from either title company's not contacting the township prior to closing or people not paying

their final bill. Dave Deutschlander **motioned** Terry Peterson seconded to write off as uncollectable Kathleen Bartheidel 11623 Sunny Drive 28.0888.000, \$49.00, Ron & Kathy Morris 11247 Lakeview Heights, 28.5427.000, \$126.66. Ron Scharmer 14957 Maple Leaf, 28.5167.000, \$1.14, John Swanson III 18961 Highwood Shores, 28.5249.000, \$226.33, Donna Vettling 11170 Lakeview Heights, 28.5436.000, \$152.83. Total balance to write off \$555.96. All in favor motion carried.

- C. Clerk Belsheim explained there are 2 CD's coming due on February 29<sup>th</sup>, the cd's need to be reinvested within 10 days of the due date. The town board looked at current interest rates. Terry Peterson **motioned** Darrin Freetly seconded to grant Administrative Clerk Christy Belsheim authority to reinvest the 2 cd's at Stearns Bank coming due on February 29<sup>th</sup>, 2024 at the bank with the best rate possible at the time. The town board suggested to invest 1 for 12-month and 1 for 24 months depending on rates. All in favor motion carried. There will be one more CD due March 21, 2024.
- D. Terry Peterson stated the treasurer's position has now been posted with no other inquires. Emeri Hagfors spoke and explained she has CTAS and Quick Book experience, she is the Clerk/Treasurer for City of Brook Park, and also does the books for her husband's logging company. She also has knowledge in utility billing. Peterson motioned Dave Deutschlander seconded to appoint Emeri Hagfors as Pokegama Township's Treasurer with hourly rate of \$21.00/hr. All in favor motion carried.
- E. Jason Zastera **motioned** Terry Peterson seconded to go over the sewer financials during the treasurer's report . All in favor motion carried.

#### BUILDING

Wayne Whited mentioned the sign above the door of the town all entrance should be replaced. the street sign also needs some attention. Dave Deutschlander will look into new sign pricing. The parking lot needs striping done for the March Elections. Terry Peterson **motioned** Dave Deutschlander seconded to approve \$200 for stripping in the parking lot. All in favor motion carried. Darrin Freetly will take care of the parking lot.

#### **CLERK**

Administrative Clerk Christy Belsheim stated she received 2 tablet quotes ranging from \$210-\$350 not including a case or keyboard from Cybert PC. There was a brief discussion on the tablets. Clerk Belsheim is to check on paper cost for 1 year and how much Cybert PC would charge to help with set up.

Jason Zastera motioned Darrin Freetly seconded to approve LJJ Contract with Section 7.4 Indemnification section removed. Jason Zastera yes, Wayne Whited yes, Dave Deutschlander yes, Darrin Freetly yes, Terry Peterson abstains due to conflict of interest.

Terry Peterson **motioned** Wayne Whited seconded to approve Resolution 2024-2 Adopting a Township Sick and Safe Time Policy. All in favor motion carried.
